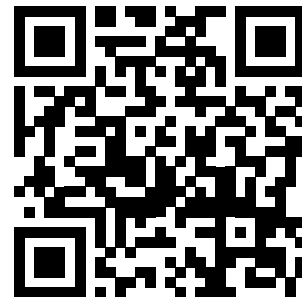

Health Cash Plan

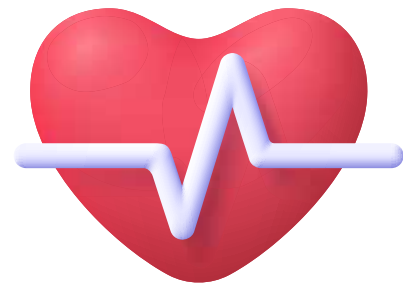
